Program Mission

The joint MBA - MS in Finance Program offered by DEREЕ - The American College of Greece aims to:

- Provide outstanding graduate education in management and finance that is international in perspective and professional in orientation.
- Provide students with a critical grounding in business, management, economics and finance that will enable them to think strategically and globally.
- Equip future professionals with specialized skills in corporate and investment finance and provide hands-on experience of simulated markets.
- Exemplify ethical behavior, standards and practices in the areas of finance and management.

Program Description

To be awarded the Joint MBA - MS in Finance degree, students must complete the degree requirements of both the MBA and the MS in Finance programs. Through proper selection of electives it may be possible to reduce the requirements of the joint degree by up to 21 credit hours compared to the normal requirements of the two degrees completed separately.

In particular, to be awarded the Joint MBA - MS in Finance degree, students must complete at least 22 courses (64 credit hours) across the major areas of business administration and Finance:

- Fifteen core courses: Ten MBA core courses and Five Finance core courses
- Two capstone courses:
 - Entrepreneurship: Business Plan Project
 - Capstone Project in Finance
- Four elective courses from the MS in Finance program
- One elective course from the MBA list of electives

Each course is scheduled for a minimum of 36 hours of direct classroom teaching and 3 hours of final assessment. All classes are held weekday evenings from 18:00 - 21:00 to permit students to continue to work while studying.

Full-time and Part-time Options

The joint MBA - MS in Finance is available in both full-time and part-time options. Part-time study options are tailored to the individual needs of working students. A student advisor helps each student develop a schedule that best meets his/her needs.

Scholarship Program
