PREREQUISITES:	SO 1000 Introduction to Sociology plus 2 additional courses in sociology	
CATALOG DESCRIPTION:	An overview of the main historical, social, economic, and cultural processes and imaginations that shaped modern Greek identity and Greek institutions such as education, religion, politics and the army from 1821 to the present. Memory and forgetting as tools of nation building. Analysis of cultural and institutional paths to the current crisis.	
RATIONALE:	Drawing on a wide range of literature, this sociology course introduces students from related social sciences and humanities into various themes relating to modern Greek identity and institution building. The constitution of past and present is discussed through themes such as tradition, modernization, clientelism, populism, authoritarianism, and democracy. To develop an understanding of contemporary political challenges, students analyze critically the tensions between continuities and discontinuities of Greek society and culture. The course locates Greece's successes and crises within the wider frame of Europe.	
LEARNING OUTCOMES:	 As a result of taking this course, the student should be able to: Apply concepts and theories to an analysis of Greek society and culture. Analyze the tension between tradition and modernization processes. Appraise issues of national and European identity. Explain the deeper causes of past and recent crises. Discuss the rise of populist parties as a result of the recent crisis. 	
METHOD OF TEACHING AND LEARNING:	 In congruence with the teaching and learning strategy of the college, the following tools are used: Classes consist of lectures and class discussions of the material assigned by the instructor. Office hours: students are encouraged to make full use of the office hours of the lecturer, where they can address issues pertinent to the course material, ask questions and seek guidance on their research paper. Use of a blackboard site, where the instructor posts lecture notes, assignment instructions, timely announcements, as well as additional resources.
