The American University of Greece (AUG) has requested initial authorization from the Board of Higher Education (BHE) to operate as a post-secondary institution in the Commonwealth and offer the degrees enumerated above. AUG will serve as the higher education academic program support organization for the American College of Greece (ACG), which is incorporated in Colorado in the US and offers a range of collegiate and pre-collegiate academic programs in Athens, Greece. Since 1981, ACG has been accredited by the New England Commission on Higher Education (NECHE), and was the first European higher education institution to be accredited by a US regional accreditor.

The public comment period for the Articles of Organization filed by the American University of Greece begins on September 28, 2022 and will close three weeks thereafter, on October 18, 2022.
