Release, Assumption of Risk, and Waiver

Statement of Purpose: In order to take part in off campus events, trips, activities ("Excursion"), supported by The American College of Greece - Deree College (the "College") in which participation is not mandatory, such as Excursions organized through the International student Services Office, the Office of student Affairs, and the Office of Athletics, the participant and/or their legal guardian if under 18 years of age, must read and sign this Disclaimer Form. This form shall be valid for all Excursions while the individual is a student at the College.

Please read and sign the following terms and conditions, which the participant understands and is obligated to adhere to:

- 1. Participation in the Excursion is not mandatory; however, I am responsible to attend all planned activities as stated in the attached program.
- 2. I exercise my own free choice to participate in the Excursion. I understand and assume all associated risks. I agree to assume all risk of personal injury or loss, bodily injury (including death), damage to or loss or destructions of any personal property occurring in connection with or arising out of participation in the Excursion.
- 3. I hereby release and discharge, indemnify and hold harmless the College, and its affiliates, member officers, agents, employees and any other persons or entities acting on their behalf, and the successors and assigns for any and all of the aforementioned persons and entities, against all claims, demands, costs and expenses, and causes of action whatsoever, either in law or equity, arising out of or in any way connected with any loss and/or bodily injury and/or disability, arising from my participation in the Excursion.
- 4. I understand and agree to assume all risks occurring in connection with travel to and from the Excursion.
- 5. The Excursion's chaperones / escorts have no obligation in any way towards the participants of the Excursion other than the planned activities during the Excursion.
- 6. I will conduct myself properly and in adherence to the scheduled program at the above location as well as any other planned group excursions.
- 7. During the whole duration of the Excursion I am bound to behave with decency and to observe the program of the Excursion and the relevant instructions as well as to avoid any behavior or action against the purposes and the security of the Excursion.

The College reserves its right to take any legal measure against me in case of any infringement from my part of the laws of the state to which the Excursion may be carried out or/and any disturbance from my part of the Excursion or/and refusal to observe the instructions of the excursion's chaperones / escorts.
- 9. I understand that if I do not follow instructions given by the Excursion's chaperon/escort while participating in the Excursion, I will be asked to return home at my own expense.
- 10. In case of any violation of the rules of the College and of my statements included herein the corresponding sanctions provided in the College's policies and procedures will be imposed.
- 11. In the event of an emergency, I grant the College permission to authorize emergency medical treatment for me for the duration of my participation in the Excursion.
- 12. I understand that the College advises me to obtain my own health and accident insurance policy to cover medical expenses associated with my participation in the Excursion.
- 13. If I am under 18 years of age, my parent(s) or legal guardian is aware of the statement of purpose and of all the above conditions and has signed this statement as an expression of their adherence to the terms.
- 14. I have had sufficient time to review and seek explanation of the provisions contained above, have carefully read them, understand them fully, and agree to be bound by them. After careful deliberation, I voluntarily give my consent and agree to this Release, Assumption of Risk, and Waiver. If the participant is under 18 years of age, the parent or guardian in consideration for this request accepts the above terms and grants permission for the student's participation.
